TERMS AND CONDITIONS

1. Exhibitor will comply with all City, County, and State laws and are solely responsible for all taxes.
2. Promoter and/or Pittsburgh Comicon employees are not responsible for any loss, damages, claims, or injury.
3. Each application will be processed on a first come first serve basis.
4. Sponsor will provide security on premises.
5. Exhibitor shall keep all designated areas clean and will not nail, screw or attach anything to the Convention Center.
6. No Pornographic Material
7. Subletting is not permitted.
8. All displays, chairs, tables and merchandise must be maintained within Exhibitor's designated area.
9. Any disruptive behavior, in the judgement of the Sponsor, by the Exhibitor, its agents, employees or representatives shall result in expulsion from the show.
10. Certificates of Authenticity will be available through Sponsor.
11. If Exhibitor fails to comply with above rules - The Pittsburgh Comicon can terminate this agreement.
12. Drinking of any alcoholic beverages is prohibited.
13. Exhibitor is responsible to provide its own insurance, if desirable, to protect Exhibitor and Exhibitor's property from damage, loss, theft, harm, or injury. Sponsor nor the Host Facility will obtain insurance on Exhibitor's behalf. Exhibitor is solely responsible for its own exhibit material, goods, samples and other property.

Exhibitor will hold harmless the Sponsor and Host Facility, or any of their respective officers, agents, employees, representatives or affiliates, from any liability, damage, loss, harm, claim, or injury to property or person or the Exhibitor, Exhibitor officers, agents, employees or other persons, whether caused by the negligence of the Sponsor or Host Facility, or from theft, fire, water, accident, or any other cause whatsoever.
15. Dealers may not leave the show until 5:00 P.M. on Sunday. Strict enforcement of this policy will be provided by promoter and Expomart security. Dealer Set Up is Thursday Only. Loading Dock will be Closed All Day Friday until Sunday at Closing
